

## Timeline related to the implementation of UNCAC

<b>I. The deposit of the instrument of accession to the United Nations Convention against Corruption</b>	
<b>Timeline</b>	<b>Description</b>
22 June 2015	The President signs the instrument of accession to the United Nations Convention against Corruption.
13 October 2015	The Ministry of Justice submits the written request to the Ministry of Foreign Affairs to inquire about the schedule of evaluation of the deposit.
9 March 2016	The Ministry of Foreign Affairs evaluates the result that the United Nations Secretariat will not accept the deposit of our country's documents regarding the international convention, and will return the instrument of accession assuredly, and thus proposes that the Ministry of Justice reports to the President via the Executive Yuan to proceed to promulgate the United Nations Convention against Corruption in accordance with the proviso of the Conclusion of Treaties Act.
29 March 2016	The Ministry of Justice submits the United Nations Convention against Corruption to the President via the Executive Yuan for promulgation.
25 April 2016	In the letter, the Executive Yuan asks that the instrument of accession be deposited with the Secretary-General of the United Nations with the assistance of our country's diplomatic allies according to the UN standards and norms and the conclusions of the International Working Group meeting on 21 April 2016 by order of the superior, and after that, submits the United Nations Convention against Corruption to the President for promulgation in accordance with Conclusion of Treaties Act where the deposit is rejected.
13 May 2016	By letter, the Ministry of Justice requests that the deposit of the instrument of accession be promoted with the assistance of the Ministry of Foreign Affairs again.
4 June 2016	In another letter, the Ministry of Foreign Affairs again observes that the United Nations Secretariat is unable to accept the deposit of our country's documents and will return the instrument of accession, and thus proposes that the Ministry of Justice carefully assess whether the case of deposit should be promoted continuously or submitted to the President via the Executive Yuan to proceed to promulgate the United Nations Convention against Corruption.
19 July 2016	The Ministry of Justice submits the case to the Executive Yuan and awaits the approvals that allows to promote the deposit continuously or report to the President to proceed to promulgate the United Nations Convention against Corruption.
27 July 2016	By letter, the Executive Yuan directs the Ministry of Justice submit the case to the President for promulgation via the Executive Yuan for promulgation in accordance with the proper procedures.
11 August 2016	The Ministry of Justice again submits the case to the President via the Executive Yuan to proceed to promulgate the United Nations Convention against Corruption, and the Convention retroactively takes effect as of 9 December 2015 in accordance with the Act to Implement United Nations Convention against Corruption.
25 August 2016	The Executive Yuan submits the United Nations Convention against Corruption to the President via the secretary-general to the President for promulgation, and the Convention retroactively takes effect as of 9 December 2015.
7 September 2016	The Presidential Order announces that the United Nations Convention against Corruption will be enforced as of 9 December 2015 determined by the Executive Yuan in accordance with Article 8 of the Act to Implement United Nations Convention against Corruption.

10 April 2014	The Ministry of Justice submits the United Nations Convention against Corruption and the draft of Act to Implement the United Nations Convention against Corruption to the Executive Yuan for review.
28 August 2014	The 3413 <sup>rd</sup> meeting of the Executive Yuan resolves to pass the United Nations Convention against Corruption and the Act to Implement the United Nations Convention against Corruption.
1 September 2014	The Executive Yuan proposes the United Nations Convention against Corruption and the draft of Act to Implement United Nations Convention against Corruption to the Legislative Yuan for deliberation.
10 April 2015	The Legislative Yuan's Foreign and National Defense Committee convenes the First Joint Meeting of the Foreign and National Defense Committee and the Judiciary, Organic Laws and Statutes Committee of the 7 <sup>th</sup> Session of the 8 <sup>th</sup> Term of the Legislative Yuan.
5 May 2015	In the 10 <sup>th</sup> meeting of the 7 <sup>th</sup> Session of its 8 <sup>th</sup> Term, the Legislative Yuan resolves to pass the United Nations Convention against Corruption and the Act to Implement United Nations Convention against Corruption.
20 May 2015	The President enacts and promulgates the Act to Implement the United Nations Convention against Corruption, consisting of eight articles, its effective date shall be set by the Executive Yuan.
22 June 2015	The President signs the instrument of accession to the United Nations Convention against Corruption.
9 December 2015	The Act to Implement United Nations Convention against Corruption is set by the Executive Yuan and takes effect on 9 December 2015.
7 September 2016	Presidential Order announces that in accordance with Article 8 of the Act to Implement United Nations Convention against Corruption, the Executive Yuan has resolved that the United Nations Convention against Corruption takes effect in the Republic of China as of 9 December 2015.
