Background:

Today, every country is competing to boost its economic growth to create a better life for its people. Hence, the need for creating a clean business climate is crucial. However, the major problems for some countries are high level of bribery and corruption. Bribery and corruption have a very destructive effect on economy and the World Bank has estimated that 0.5 % of GDP lost through corruption. The corrupt practices have created a very unfavorable business environment by encouraging unfair advantage and anti-competitive practices.

Reflecting on this fact, the partnership between public and private sector becomes a very significant issue in preventing corruption. Bribery, gratuity and facilitation payment are common in business practices and all of them are about “supply” and “demand”. Companies that might otherwise be tempted to bribe represent the “supply” side, while corrupt public officials occupy the “demand” side of equation. Therefore, it is crucial to cope with these problems.

Related to facilitation payment or “grease payment”, the 2009 Recommendations of the OECD Convention on Combating Bribery of Foreign Public Officials in International Business Transactions, calls its member to review their policies and approaches on small facilitation payments and encourages companies to prohibit the use of facilitation payments through the implementation of internal company controls, ethics and compliance programmes. Nevertheless, the differences between the gift and facilitation payment regulations have been recognized as a challenge in creating more transparent and accountable business environment. In other words, Gift-giving and facilitation payments are regulated differently in each country.

As the Chair of the APEC Anti-Corruption and Transparency Working Group (ACT) 2013, Indonesia is pleased to host this workshop to discuss this issue with all ACT member economies and invited international organisations. We invite ACT members to share their experiences, best practices, gift-giving regulations, challenges and strategies on how the facilitation payments are affecting the efforts to fight bribery. We believe that it would be a great opportunity to share with other ACT Working Group member economies’ experiences in preventing facilitation payment and managing gratuities. Furthermore, with their particular insight, along with their experience, the workshop participants will have the chance to exchange information and suggest ways to strengthen cooperation amongst ACT members.
