Environmental Conservation and Enterprise Integrity Forum:
Responsibility, Sustainability, and Competiveness;
Fulfill enterprise integrity, and demonstrate the will for
anti-corruption acts

On Monday, December 5th, 2016, the AAC of the Ministry of Justice cooperated with Taoyuan City Government in hosting the National Defense and Enterprise Integrity Responsibility, Sustainability, and Competitiveness Forum. The forum is part of 1209 International Anti-Corruption events. Many who are concerned about environmental sustainability and protection from governments, enterprises, and the academic field participated in the event. There were approximately 160 people who participated.

Chiu Tai-Shan, the Minister of Justice said that the UN Convention passed the Act to Implement United Nations Convention against Corruption in 2003. Despite ROC not being a member of the UN, in order to promote the anti-corruption acts and policies of the the Executive Yuan has convention, executed certain domestically, ensuring the legal effects of the convention within the country. The goal is to improve the prevention and anti-corruption system, enhance international cooperation on the policy, technical information trading, illegal reclaim assets, support, government transparency and accountability, reinforce the cooperation between public and private sectors as well as social participation.

Chiu indicated that from November 9th to December 9th, the AAC worked with central and local governments to host a series of

international anti-corruption events nationwide, hoping to build public trust toward the government and increase enterprise integrity. The theme of the forum today is environmental protection and enterprise integrity. In addition to prosecuting illegal activities, obstacles that stop the city from improving, have to be eliminated too. It also aims to assist and promote various cooperate projects between the government and enterprises, so as to elevate the competence of the country and reach sustainable development.

Zheng Wen-Tsan, the Mayor of Taoyuan City, indicated that openness is an important declaration for the new city administration. The mayor has no other agents or so-called "cover-up", nor is there anyone who can represent the mayor himself. Every issue can be brought to the city hall and will be recorded in order to achieve transparency within the governments, stopping the custom of factions pulling strings from above.

In the speech, Mayor Zheng also introduce the New United Accountability Mechanism, made up by alliances including: Executive Yuan, Environmental Protection Administration, Taoyuan Environment Protection Department, Police Stations, and Taoyuan Prosecutors Office. For those who violate environmental crimes such as violation of land preservation, waste disposal...etc, these violations belongs to Normal Administrative Punishment under the supervision of Environment Department of each City Halls. If the violation has relation with crime liability, the case will be handed over to Taoyuan Prosecution Office. With these measure, can truly deter environment crime from happening.

The forum is focused on environmental protection and sustainability. Minister Chiu, Minister Zheng, Peng Kun-Yeh, Head
